Ministry Updates:

Addiction and Mental Health/Health Support- no meeting Building Community- No meeting was held. Red Cross chose Easter week, will try to change this.

Finance- December- trend in giving has increased. Down for November 36,582. We have spent 36,000 more than we have taken in. We have borrowed from our Memorial Fund.

Property-Roof is leaking in different spots. New air conditioning company is being explored. Our new sign is having problems. Laura will be communicating with the company. We have over 1600 non-church meetings in a year at POP. Next year we will make posters and let others know. Minutes attached.

Stewardship-Congregation is very generous. We have given \$45,000 not in the budget. We are putting together a brochure with facts that we will share with the congregation. Worship, learning, support, administration and giving. This is a Mission Budget. Paints an exciting picture of what we do here at POP. This will be given out in multiple ways, mailing, bulletin, website. Shows where the staff spend their time. Liz and Pastor have been working on this.

Old Business-
